- B. **PUBLIC HEARING**
1. The purpose of the Public Hearing is to receive input from the public, either oral or written, regarding the 2019 proposed property tax rate to support the 2020 Budget.

### **REGULAR AGENDA**

1. Discussion and possible action to approve a budget amendment to increase the Village Fire Department 2020 budget by the amount of \$1.5 million to be placed in Facility Fund 4.
- C. **EXECUTIVE SESSION** It is anticipated that all, or a portion of the discussion of the following items will be conducted in closed executive session under authority of the Texas Open Meetings Act. Situations in which a closed executive session may be authorized by law include, without limitation; (1) certain consultations with the City's attorney under §551.071.
- D. **RECONVENE** into Open Session and consider action, if any, on items discussed in Executive Session.
- E. **ADJOURNMENT**

The City Council may convene a public meeting and then recess into closed executive session, to discuss any of the items listed on this agenda, if necessary, and if authorized under chapter 551 of the Texas Government Code. Situations in which a closed executive session may be authorized by law include, without limitation; (1) consulting with the Council's attorney to seek or receive legal advice concerning pending or contemplated litigation, a settlement offer, or any other matter in which the ethical duty of the attorney to the Council clearly conflicts with the general requirement that all meetings be open, § 551.071; (2) discussing the purchase, exchange, lease, or value of real property, § 551.072; (3) discussing a prospective gift or donation, § 551.073; (4) discussing certain personnel matters, §551.074; and (5) discussing security personnel or devices, § 551.076.
