- B. **PUBLIC HEARING**
1. The purpose of the Public Hearing is to receive input from the public, either oral or written, regarding the 2017 proposed property tax rate to support the 2018 Budget.

- C. **REGULAR AGENDA**
1. Discussion and possible action regarding the City's continued participation in the Tri-Cities Virtual Gate Committee.
  2. Report from Mayor on City's response to Hurricane Harvey and discussion and possible action to address disaster recovery items that might require immediate action.
- D. **EXECUTIVE SESSION** It is anticipated that all, or a portion of the discussion of the following items will be conducted in closed executive session under authority of the Texas Open Meetings Act. However, no action will be taken on these items until the City Council reconvenes in open session. Situations in which a closed executive session may be authorized by law include, without limitation; (1) certain consultations with the City's attorney under §551.071.
- E. **RECONVENE** into Open Session and consider action, if any, on items discussed in Executive Session.
- F. **ADJOURNMENT**

The City Council may convene a public meeting and then recess into closed executive session, to discuss any of the items listed on this agenda, if necessary, and if authorized under chapter 551 of the Texas Government Code. Situations in which a closed executive session may be authorized by law include, without limitation; (1) consulting with the Council's attorney to seek or receive legal advice concerning pending or contemplated litigation, a settlement offer, or any other matter in which the ethical duty of the attorney to the Council clearly conflicts with the general requirement that all meetings be open, § 551.071; (2) discussing the purchase, exchange, lease, or value of real property, § 551.072; (3) discussing a prospective gift or donation, § 551.073; (4) discussing certain personnel matters, §551.074; and (5) discussing security personnel or devices, § 551.076.
