CITY OF HUNTERS CREEK VILLAGE, TEXAS MINUTES OF THE PLANNING & ZONING COMMISSION July 8, 2021

The Planning and Zoning Commission of the City of Hunters Creek Village, Texas, convened a regular meeting on July 8, 2021 at 6:00 p.m. in the City Hall at #1 Hunters Creek Place, Hunters Creek Village, Texas. Members of the public were invited to attend the meeting in person or by video or audio conference.

The meeting was called to order at 6:00 p.m. by Chairman Bill Dalton. In attendance were Commissioners Bill Dalton, John Abercrombie, David Childers, Brent Fredricks and Alternate Commissioner Rob Adams attending in Charles Martin's absence. Also, in attendance were: John Hightower, City Attorney; Tom Fullen, City Administrator; and James Stewart, City Building Official.

- A. Call the meeting to order and the roll of appointed officers will be taken.
- B. **PUBLIC HEARINGS**. Public hearings will be held before the Planning & Zoning Commission for the purpose of receiving testimony for or against the following proposed zoning amendments:

The Commission elected to reverse the order of the public hearings from what was shown on the meeting agenda.

1. A proposal to amend the specific use permit for the Houston Racquet Club to: remove the decibel limits on music emanating from the Club; prohibit the playing of music at the Club between the hours of 11:00 pm and 7:00 am; and require the Club to comply with the noise restrictions applicable to the City's residential zoning district; and

The Public Hearing was opened at 6:07 p.m.

Comments: Comments were received from the public, including several homeowners residing on the Ripple Creek and Pinewood Circle streets near the Houston Racquet Club who registered their opposition to the proposed amendment.

The Public Hearing was closed at 7:02 p.m.

2. A proposal to amend the specific use permit for the Hunters Creek Elementary School campus located at 10650 Beinhorn Road, Houston, Texas, 77024, to allow the installation of Building Identification Signage and the installation and operation of a marque electronic message sign, under certain conditions.

The Public Hearing was opened at 6:02 p.m.

Comments: There were no public comments on this item.

The Public Hearing was closed at 6:05 p.m.

Commissioner Fredricks made a motion to approve the minutes of the June 21, 2021 meeting. Commissioner Abercrombie seconded the motion and the motion carried unanimously.

EXHIBITS: Specific Use Permit & Request from the Church

The original specific use permit for the Chinese Baptist Church was issued as a specific use exception by the Board of Adjustment. The specific use permit process has since changed and now all specific use permit and amendment requests are heard by the Planning and Zoning Commission and granted by City Council.

A Specific Use Exception was granted by the Board of Adjustment on June 10, 2013 for the construction of the new Sanctuary Building currently located on the property. On January 24, 2017, Ordinance Number 2017-871 granted a Specific Use Permit for the operation of a Day School on the Church premises.

The Chinese Baptist Church is requesting a Specific Use Permit to add two canopies, one on the east side of the existing Worship Building, and the other on the east side of the existing Education Building. These proposed locations are shown as #1 and #2 on the site plan included with their request. The purpose of these canopies is to protect patrons as they enter and exit the buildings.

A photograph is also included depicting a canopy similar to what is being proposed. The Architectural Drawings for the exact canopies are being prepared, but have not yet been finished.

ORDINANCE NO. 2017-871

AN ORDINANCE OF THE CITY OF HUNTERS CREEK VILLAGE, TEXAS, AMENDING THE ZONING CHAPTER TO GRANT A SPECIFIC USE PERMIT FOR THE CHINESE BAPTIST CHURCH PROPERTY TO ALLOW THE OPERATION OF A DAY SCHOOL ON THE CHURCH PREMISES AT 900 BROGDEN SUBJECT TO CERTAIN LIMITATIONS AND CONDITIONS, INCLUDING LIMITATIONS ON THE NUMBER OF STUDENTS AND THE HOURS OF OPERATION: AND CONTAINING **FINDINGS** OTHER **PROVISIONS** RELATING TO THE SUBJECT; PROVIDING A PENALTY IN AN AMOUNT NOT TO EXCEED \$2000; AND PROVIDING FOR SEVERABILITY.

WHEREAS, the Chinese Baptist Church (the "CBC") is the owner of a tract of land, TRS 6C & 96, Harris County, Texas, that is further identified as 900 Brogden Road, Houston, Texas (the "Church Premises"), and that is situated within the corporate limits of the City of Hunters Creek Village, Texas;

WHEREAS, the CBC has established and operates a church on the Church Premises in compliance with the City's Zoning Chapter;

WHEREAS, the Church Premises are located in District R (Single Family Residential) under the City's Zoning Chapter;

WHEREAS, under the Zoning Chapter, church uses are permitted in District R by specific use permit;

WHEREAS, CBC, acting through its duly authorized representative, has presented an application to the City to amend the Zoning Chapter to grant CBC a Specific Use Permit to allow the operation of a day school on the Church Premises under certain limitations and conditions;

WHEREAS, the City Council finds that the operation of a day school on the Church Premises under the conditions set out in this Ordinance is incidental to and consistent with the current use of the Church Premises as a church;

WHEREAS, the Zoning Commission of the City, after notice and hearing as required by law, has recommended that the City Council grant the requested amendment subject to certain limitations and conditions; and

WHEREAS, the City Council, after notice and hearing as required by law, concurs with the recommendation of the Commission; now therefore

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HUNTERS CREEK VILLAGE, TEXAS:

<u>Section 1</u>. The findings contained in the preamble of this Ordinance are adopted.

<u>Section 2</u>. A specific use permit is hereby granted to the Chinese Baptist Church to allow the operation of a day school on the church premises located at 901 Brogden Road under the following limitations and conditions:

- a. Hours of operation for the school limited to: i) 7:30 am to 4:45 pm, Monday, Wednesday, and Friday for regular school activities; and ii) no more than four special events a month to be held after the close of regular school hours and to be concluded by 10:00 p.m.
- b. Number of students The total number of students is limited to 350.
- c. <u>Student drop off and pickup</u> Drop off and pick up of students shall be staggered, with release in groups of no more than 8 or 10 cars at a time.
- d. <u>Traffic Control</u> The School shall provide traffic control and security through the Memorial Village Police Department on an as needed basis to minimize the impact on the neighborhood.
- e. <u>Building Code</u> Any church facilities used by the school must meet all applicable building code requirements.
- f. Outdoor sports activities No outdoor sports activities shall be allowed on the Church Premises, other than running or walking.

<u>Section 3</u>. Any person who shall violate any provision of this Ordinance shall be deemed guilty of a misdemeanor and, upon conviction, shall be fined in an amount not to exceed \$2,000. Each day of violation shall constitute a separate offense.

Section 4. In the event any clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it is the intention of the City Council that the invalidity or unconstitutionality of the one or more parts shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision other than the part declared to be invalid or unconstitutional; and the City Council of the City of Hunters Creek Village, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.

We request to have a hearing at the next City Council meeting on Tuesday, July 27th.


