  - (a) Presentation and discussion of the proposed final replat filed by Brian Freed of the Bridgewood Partial Replat, a subdivision containing 1.11 acres being a replat of Lots 6 and 7 of the Bridgewood Replat situated in the J. D. Taylor Survey, A-72, also known as 10929 Bridgewood, City of Hunters Creek Village, Harris County, Texas to combine Lots 6 and 7 into one lot and modify the 40' drainage easement for Soldiers Creek.
  - (b) Public Hearing for the purpose of receiving testimony for and against the approval of the final re-plat described in Item 2(a) above.
