others in, but there was a considerable delay in calling the police. Utility workers should be in a clearly marked vehicle and wear distinct uniforms with their name and utility name displayed. If you think something is abnormal, it probably is. Please call the police department (713-365-3700) if you have any questions about someone knocking on your door or wanting to work in your house. Utility workers should NEVER ask to work inside your house or come inside.
